The meeting was initiated with a welcome address by the President SSB followed by a discussion on the proceedings of the last meeting, especially on the response of the bidders during the auction of the damaged and unusable furnitures and equipments of the SSB. The actions taken by the Secretary, SSB in connection with the auction and the deposit of Rs. 22,910/- (Rupees Twenty Two Thousand & Nine Hundred Ten) only in the appropriate government fund etc. were discussed and appreciated. The preparation relating to the initiation of the recruitment of lecturers against the vacant Direct Payment posts in the 488 category of non-government aided colleges as well as the vacant sanctioned posts in the SSB office were discussed in detail and the following resolutions are unanimously adopted;

- 1. That, the Secretary, SSB is requested to send reminders to all the colleges; those have not yet submitted the subject-wise vacancies against the Direct Payment sanctioned posts of their colleges, to submit the same by 30th April, 2015.
- 2. That, the Directorate of Higher Education be requested to provide up to date college & subject wise vacancy positions in the 488 category of colleges by 30th April, 2015 to authenticate the informations received by the SSB in connection with the vacant DP posts.
- **3.** That, the Secretary, SSB is requested to inform the colleges on the vacancies that they have submitted to the Board through e-mail with a request to authenticate the same through the reply mail. No hard copy is required.
- **4.** That, the draft proposal on the procedure of selection of the lecturers against the vacant DP posts by the Secretary, SSB, with reference to the criteria adopted by different recruiting agencies were discussed and some more time is allowed to prepare the same in detail.
- **5.** That, the problems and the constraints of proper functioning of SSB due to non availability of adequate space was discussed in detail and the Board felt to request the Higher Education Department to instruct the Regional Director, Bhubaneswar to vacate the SSB building at the earliest, for making due preparation for the initiation of the recruitment process.
- **6.** That, the next meeting of the board is scheduled to be convened during the last week of April, 2015.

The meeting ended with a vote of thanks proposed by the Secretary, SSB.
